Top-Two Primary Act

The Top-Two Candidates Open Primary Act, approved by the voters in 2010, changes the way U.S. Senate, Congressional, State Senate, and State Assembly offices are elected. The two candidates with the highest number of votes in the Primary Election move to the General Election regardless of party.

California's Voters Choice Act

Passed in 2016, the Voters Choice Act (VCA) transitioned us from Polling Places to larger Vote Centers. These Vote Centers allow people to vote anywhere in Sacramento County, rather than being assigned to a specific Polling Place. The VCA also extended the amount of time Voters have to cast their vote. All registered voters in Sacramento are mailed a ballot 28 days before Election day as you now have the option to Vote by Mail. Vote Centers are open for either 11 days or 4 days to allow for early in-person voting as well.

How will I know the results?

Once the results from your school have been tallied (within 72 hours, excluding weekends), they will be emailed to your teacher and posted online. - Complete paid mandatory training (self paced online training podcast episodes and self schedule an in-person training at our office 7000 65th St, Suite A Sacramento CA 95823)

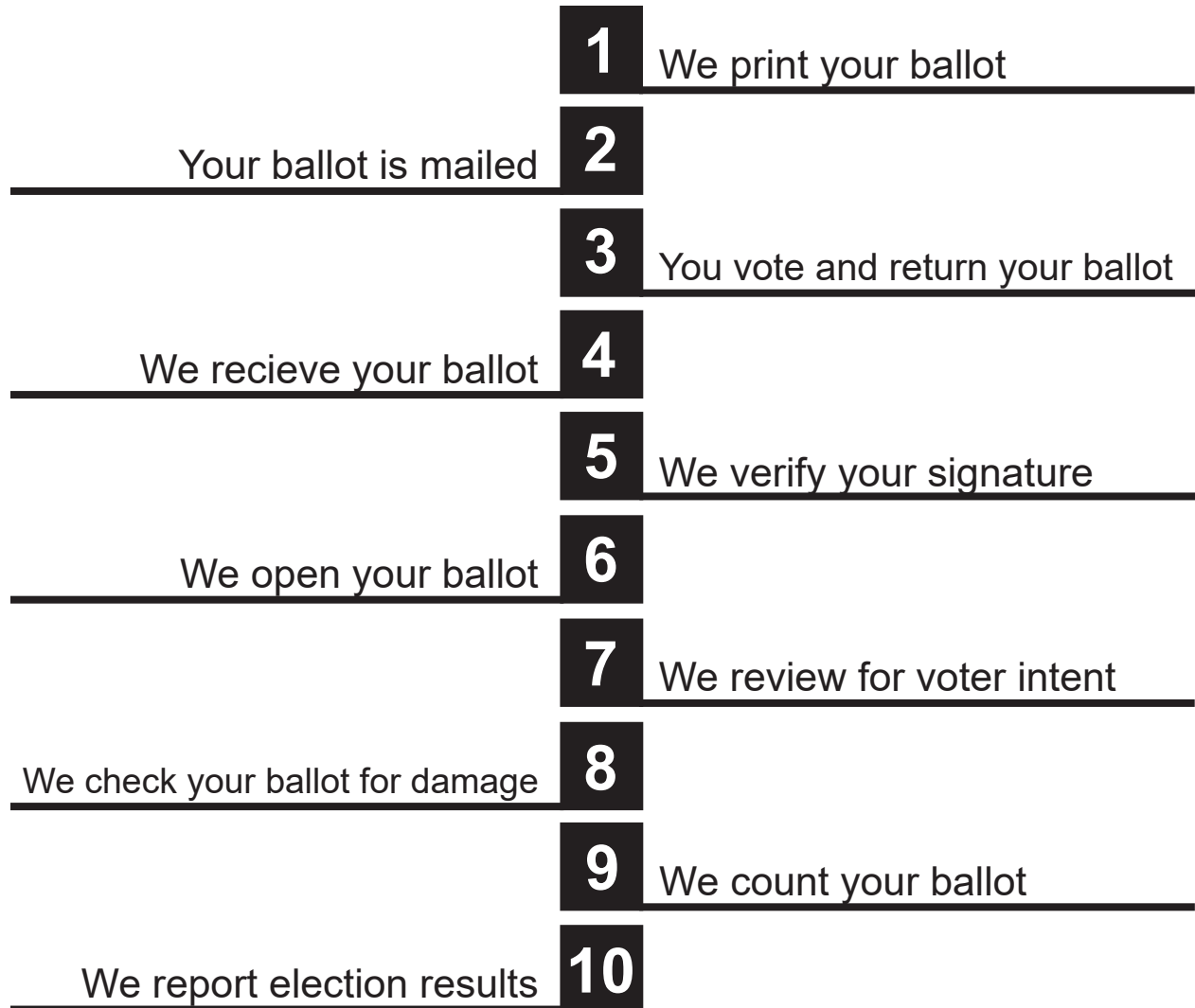
Get Paid!

- Earn \$15.50/hr plus an extra \$0.80/hr if bilingual
- Students under 18 years of age may work a maximum of 2 days
- Work election day (15 hour shift) and one early voting day (up to 10 hours)
- Payroll is processed 4 to 6 weeks after Election Day

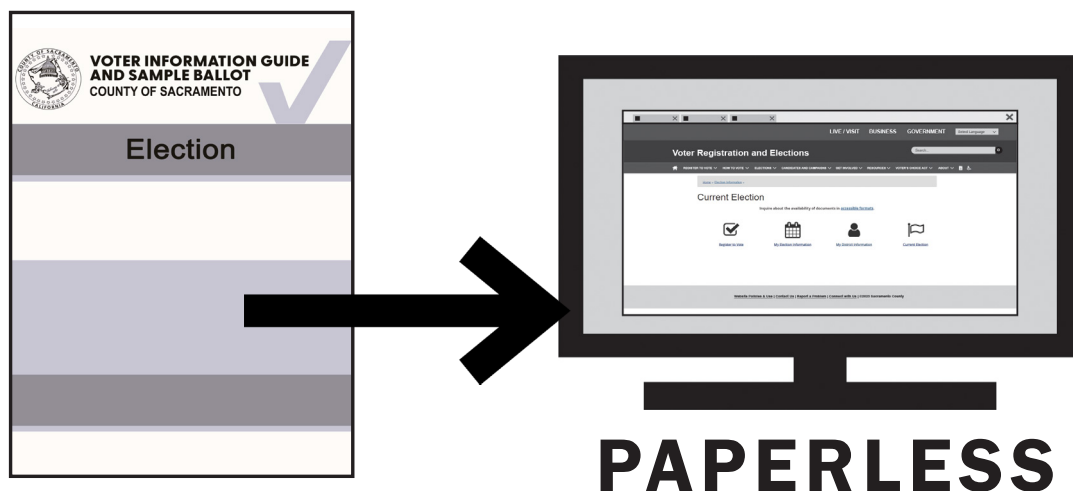
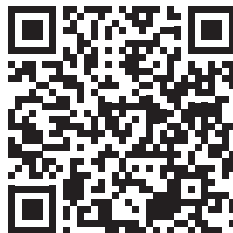

Tony Stark

No Party Preference

Tony kept his alter-ego a secret for most of his career, juggling his responsibilities as head of Stark Industries while becoming a key player in the superhuman community as Iron Man and founding the world's premier super hero team, the Avengers. Over the years, Stark has faced numerous enemies, such as the Mandarin, Justin Hammer, Iron Monger, and the Titanium Man, as well as many personal demons, most notably his addiction to alcohol. For many years, Tony covered for his alter-ego by claiming that Iron Man was his anonymous bodyguard, but Tony eventually brought his dual identity to the public light. Although he stepped up to the mark, the lack of proper calibrations in the armor affected Rhodey's psyche and he had to step down, paving the way for Tony to return as Iron Man. Later on, after Stark was seemingly assassinated, Rhodey reluctantly heeded Tony's will and became Iron Man again, wearing a new armor made specifically for him. Once he learned that Stark had survived in secret, Rhodey temporarily cut ties with him, and went solo, adopting the alias of War Machine. Steve Rogers

Cpt. Steven Grant "Steve" Rogers a.k.a. Captain America, the First Avenger, was rejected by the U.S. Army during World War II due to numerous health problems. He ultimately volunteered for Project Rebirth where he received the Super-Soldier Serum developed by Dr. Abraham Erskine. The serum greatly enhanced his frail body to the peak of human physicality. As the Sentinel of Liberty, alongside his best friend Bucky Barnes and the Invaders, Rogers and others helped the Allies win the war, but not before he was lost at sea and frozen in ice in a form of suspended animation for decades. He was thawed out in the modern age to continue the battle alongside his new allies the Avengers. His memory was returned to him decades later and he became the new Captain America after Steve Rogers was seemingly murdered and also joined the Avengers. Sam Wilson

No Party Preference

Sam Wilson combats violence and inequality in Harlem not only as a prestigious social worker but also as the soaring superhero known as Falcon or Captain America. Having been secretly manipulated by the villainous Red Skull into becoming a partner to Steve Rogers, the original Captain America, Wilson ended up forging a deep friendship with the star-spangled hero as well as a reputation as a renowned hero by himself. Due to having been affected by the Red Skull's Cosmic Cube, Wilson has been granted the ability to psychically connect with avian forms with life, in special, his pet bird Redwing.

Constantly having different ideologies and interpretations on various matters, Rogers and Wilson have evolved together by sharing their perspectives. Wilson has served alongside Earth's Mightiest Heroes, the Avengers, and, in different moments, assumed the role of leader of the group as a replacement for Steve Rogers.

Permanently adopting the mantle of Captain America, Sam Wilson has become a symbol for an alternative representation of the country. However, he faced several challenges in this role. As Captain America, he was pivotal in combating the empire of Hydra, managing to bring its fall. More recently, Captain America expanded his actions to help the entire world. Wanda Maximoff, the Scarlet Witch, is a Romani sorceress and twin sister of the speedster Quicksilver. Once believed to have been mutant children of Magneto, the twins are in truth orphans enhanced by the High Evolutionary at Mount Wundagore in Transia. The Scarlet Witch became a conduit of chaos magic, allowing her to shift probabilities and warp reality itself by casting various "hexes". After being saved from an angry mob by Magneto, the Scarlet Witch and her brother joined the Brotherhood of Evil Mutants to fight for Magneto's mutant supremacy cause. Disagreeing with Magneto's ruthless approach to human hostilities towards mutants, the twins left him and joined the super-heroic Avengers instead.

The Scarlet Witch was trained by Agatha Harkness to explore her naturally powerful magical abilities. She also had in the demon lord of chaos Chthon an archnemesis. As an Avenger, Maximoff fell in love with and married her synthezoid teammate, the Vision. In order to have a family with her artificial husband, she used her abilities to conceive two twin boys, but the spell was later broken, erasing both boys from existence, a tragedy that was accompanied by her husband being dismantled. The trauma of losing her family made her mentally vulnerable. After she attacked the Avengers twice, the group disassembled. Subsequently, in a major, erratic display of her powers, the Scarlet Witch reshaped reality under the rule of the House of M, based on Magneto's wishes. As the Avengers and the X-Men battled, to restore reality, she uttered the words "No More Mutants", wiping out the super-abilities of most mutants in retaliation to Magneto's extremism. This action became known as the mutant decimation.

For years, after a long way to rejoin the Avengers, the Scarlet Witch has been haunted by her actions in a journey for redemption, which culminated in the creation of the Waiting Room to revive lost mutants. More recently, she found herself dealing with the threat of Chthon once again by getting into contact with his cursed tome, the Darkhold. Moreover, she currently runs the Emporium, a witchcraft

Mary Jane Watson

No Party Preference

Mary Jane is an empathetic and understanding person, willing to give the benefit of the doubt to friends and take the time to wrap her head around something. Having grown up in an abusive household due to her father's teaching positions and frustrations in private, Mary Jane coped with the emotional trauma by acting with an extroverted personality, which was useful in her pursuits of an acting career.

Mary Jane is also shown to be a dedicated person as she kept pursuing her acting career and worked hard to open a business. Due to her training as an actress, she also has great insight and almost always knows when someone is pretending or lying. She is also an exceptionally trustworthy character, having kept Peter's secret identity as Spider-Man since high school on the night Uncle Ben died, seeing him exit his room in costume and not telling anyone. Yelena Belova

Yelena Belova is a superspy forged to be an exemplar Black Widow in the Red Room academy. Obsessed with the traitorous Black Widow Natalia Romanova, Belova has undergone intensive training to surpass her idol. In order to teach a lesson, Romanova designed a cruel scheme to show Belova that being a spy meant being used and it bore no glory or heroism. This caused Belova to abandon her masters to walk her own path.

Working as a S.H.I.E.L.D. agent for a corrupt faction, Belova was severely wounded in the Savage Land. She was offered help by the outlaw A.I.M. and was transformed into a Super-Adaptoid in exchange of attacking the Avengers. Belova stayed involved with A.I.M. in different situations, even becoming the Minister of State of their own nation in Barbuda. She met her end in a war between A.I.M. and S.H.I.E.L.D.'s Avengers.

The Red Room had ways to recover their prominent agents via cloning, including Romanova and Belova. Romanova ruined their operations, but has managed to fully restore Belova to life by psychically infusing a clone with her memories. Monica Rambeau

Demonstrating light and energy manipulation at a young age, Monica Rambeau hid and suppressed those abilities until she was bombarded with extra-dimensional energy emitted by a stolen device. Rambeau, now a harbor patrol officer, then discovered an ability to convert her body mass into any form of energy of the electromagnetic spectrum, granting her the alias of Captain Marvel. Unable to achieve success in the navy as she faced adversities as a black woman, Rambeau met recognition with the Avengers. Her competence led her to become one of the most trustworthy members of the group and, in due course, their chairwoman.

Succumbing to a tragic fate when the Avengers were betrayed by Doctor Druid, Rambeau was once gravely wounded in combat and lost her powers. After a slow recovery, she was welcomed back to the Avengers, sporadically assisting the team in times of need under the name Photon. In another dramatic turn of events, Rambeau was manipulated by the Beyond Corporation into commanding their super hero team, Nextwave. Upon learning their vile intentions, Rambeau and her team went rogue and dismantled Beyond. However, she was forever scarred by such an experience, having her personality drastically changed by it.

As Spectrum, Rambeau became a prominent super hero as a member of the Mighty Avengers, the Ultimates, and Strikeforce. Having her power levels significantly augmented, Rambeau struggled with feeling distant from her sense of humanity. Unexpectedly, after battling the goddess of the night, Nyx, her powers declined, allowing her to become human again.

More recently, she returned to her Photon identity and embarked on a self-discovery journey. REGISTERING AS NO PARTY PREFERENCE (NPP)

Voters who registered to vote without stating a political party preference are known as No Party Preference (NPP) voters. NPP voters were formerly known as “decline-to-state” or “DTS” voters.

VOTING IN PRESIDENTIAL PRIMARY ELECTIONS

For presidential primary elections: NPP voters will receive a “non-partisan” ballot that does not include presidential candidates. A nonpartisan ballot contains only the names of candidates for voter-nominated offices and local nonpartisan offices and measures. However, NPP voters may vote in a political party’s partisan election if the political party, by party rule duly noticed to the Secretary of State, authorizes NPP voters to vote in the next presidential primary election. An NPP voter may request the ballot of one of the political parties, if any, that authorizes NPP voters to vote in the presidential primary election.

CLOSED PRIMARY SYSTEM

A “closed” primary system governed California’s primary elections until 1996. In a closed primary, only persons who are registered members of a political party may vote the ballot of that political party.

OPEN PRIMARY SYSTEM

The provisions of the “closed” primary system were amended by the adoption of Proposition 198, an initiative statute approved by the voters at the March 26, 1996, Primary Election. Proposition 198 changed the closed primary system to what is known as a “blanket” or “open” primary, in which all registered voters may vote for any candidate, regardless of political affiliation and without a declaration of political faith or allegiance. On June 26, 2000, the United States Supreme Court issued a decision in *California Democratic Party, et. al. v. Jones*, stating that California’s “open” primary system, established by Proposition 198, was unconstitutional because it violated a political party’s First Amendment right of association. Therefore, the Supreme Court overturned Proposition 198.

MODIFIED CLOSED PRIMARY SYSTEM FOR PRESIDENTIAL ELECTIONS

California’s current “modified” closed primary system for Presidential elections was chaptered on September 29, 2000 and took effect on January 1, 2001. Senate Bill 28 (Ch. 898, Stats. 2000) implemented a “modified” closed primary system that permitted voters who had declined to provide a political party preference (formerly known as “decline to state” voters) to participate in a primary election if authorized by an individual party’s rules and duly noticed by the Secretary of State.

TOP TWO CANDIDATES OPEN PRIMARY ACT AND VOTER-NOMINATED OFFICES

The Top Two Candidates Open Primary Act, which took effect January 1, 2011, requires that all candidates for a voter-nominated office be listed on the same ballot. Previously known as partisan offices, voter-nominated offices are state legislative offices, U.S. congressional offices, and state constitutional offices. Only the two candidates receiving the most votes—regardless of party preference—move on to the general election regardless of vote totals.

Write-in candidates for voter-nominated offices can only run in the primary election. However, a write-in candidate can only move on to the general election if the candidate is one of the top two vote-getters in the primary election.

Additionally, there is no independent nomination process for a general election. California’s new open primary system does not apply to candidates running for U.S. President, county central committee, or local offices.

PARTY-NOMINATED/PARTISAN OFFICES

No voter may vote in the primary election of any political party other than the party he or she has disclosed a preference for upon registering to vote. However, a political party may authorize a person who has declined to disclose a party preference to vote in that party’s primary election.

VOTER-NOMINATED OFFICES

All voters may vote for any candidate for a voter-nominated office, provided they meet the other qualifications required to vote for that office. The top two votegetters at the primary election advance to the general election for the voter-nominated office, even if both candidates have specified the same party preference designation. No party is entitled to have a candidate with its party preference designation participate in the general election unless such candidate is one of the two highest votegetters at the primary election.

NONPARTISAN OFFICES

Under the California Constitution, political parties are not entitled to nominate candidates for nonpartisan offices at the primary election, and a candidate nominated for a nonpartisan office at the primary election is not the official nominee of any party for the office in question at the ensuing general election. A candidate for nomination or election to a nonpartisan office may not designate his or her party preference, or lack of party preference, on the primary and general election ballot. The top two votegetters at the primary election advance to the general election for the nonpartisan office.

MOCK ELECTION LOCATIONS

Vote Centers replaced traditional polling places in 2018. They give voters the opportunity to visit any convenient location and:

- Vote in-person
- Get a replacement ballot
- Drop off your voted ballot
- Register to vote or update your registration before voting
- Accessible Voting Booths are available

For our Mock Elections, participating High Schools are serving as a Ballot Drop Box location!

During an election, Vote Centers may be open for either 11 or 4 days. Your CVIG will let you know what days a Vote Center is open, along with the hours of operation and what Language Assistance is available at that location. On Election Day, all Vote Centers are open 7am - 8pm!

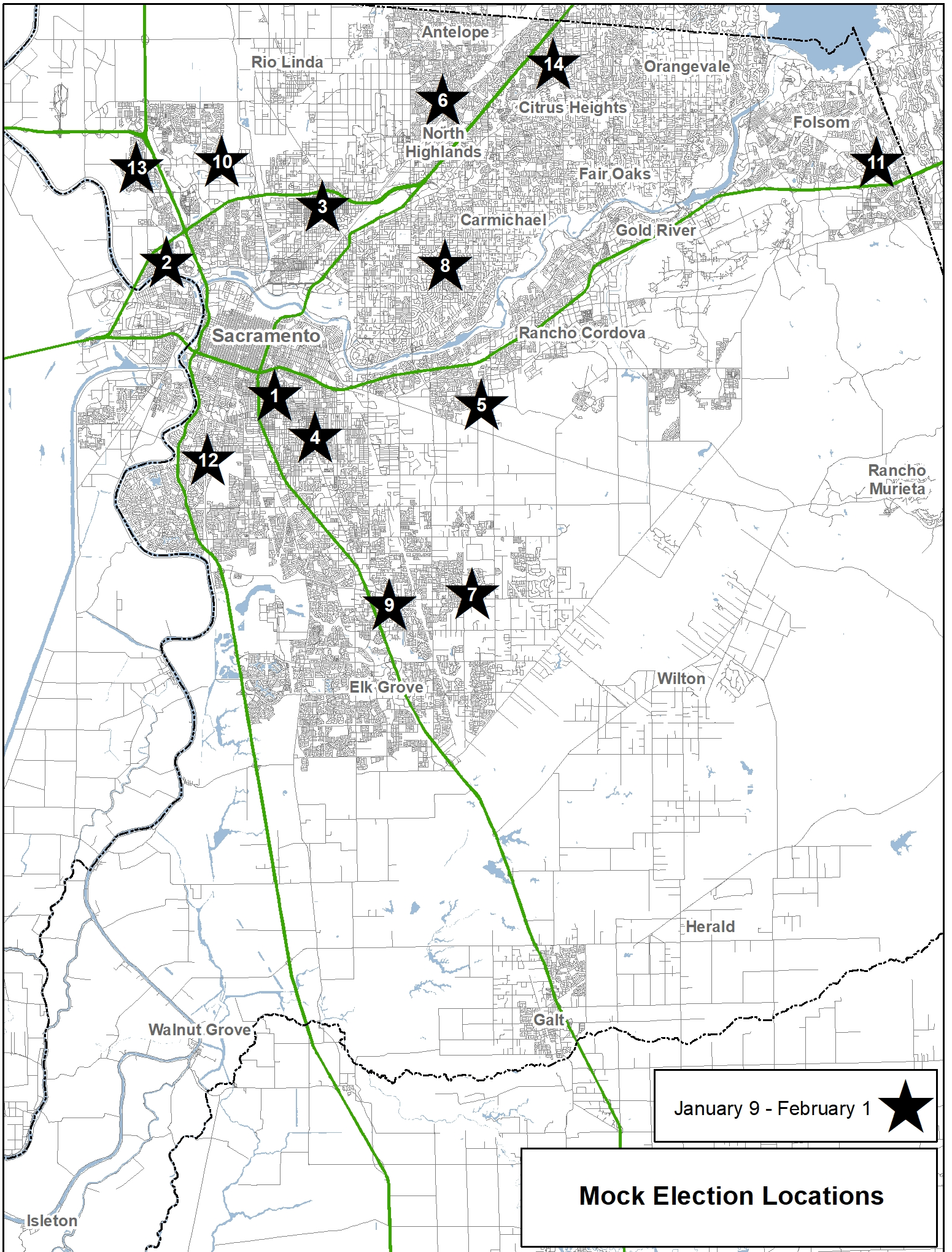
