

NOTICE OF INTENTION TO CIRCULATE RECALL PETITION

TO THE HONORABLE SASCHA VOGT: Pursuant to Section 11020, California Elections Code, the undersigned registered qualified voters of the Twin Rivers Unified School District, Trustee Area 7, hereby give notice that we are the proponents of a recall petition and that we intend to seek your recall and removal from the office of Trustee in the Twin Rivers Unified School District, and to demand election of a successor in that office. The grounds for the recall are as follows:

Trustee Vogt has not lived up to the promises she made to TRUSD voters, parents and staff.

Despite being elected on a platform of transparency, collaboration, and investing in classrooms, she was unwilling to engage with educators and the community to resolve our historic 12 day strike.

She refused to meet with educators during the 13 months preceding the strike.

She supported the ongoing practice of underfunding our classrooms by seeking a waiver to minimum funding required by law. Continuing the practice of her predecessor which goes back more than 6 years.

After the strike, she chose secrecy over collaboration by refusing to include a community panel during the search for a new Superintendent, denying stakeholder's request to include parent and staff input.

Despite widespread opposition from educators, parents, and community she supports the District's workforce housing project. A project that has cost our district millions of dollars and countless hours of work and attention which should have been directed toward classrooms.

Trustee Vogt has not lived up to her promises as a school board and has failed TRUSD students and families. For these failings Trustee Vogt should be recalled.

Elections Code section 11023. (a) Within seven days after the filing of the notice of intention, the officer sought to be recalled may file with the elections official, or in the case of a state officer, the Secretary of State, an answer, in not more than 200 words, to the statement of the proponents. (b) If an answer is filed, the officer shall, within seven days after the filing of the notice of intention, also serve a copy of it, by personal delivery or by certified mail, on one of the proponents named in the notice of intention. (c) The answer shall be signed and shall be accompanied by the printed name and business or residence address of the officer sought to be recalled.
